FUNCTIONS OF THE TRUST BOARD in Point No 10 sub clause 19 and 20 in Page 12 to appoint, expel, terminate or add new trustees in the Trust Board on such terms and conditions as it decides.

The Trust Amendment is done as per the clauses mentioned in the earlier Deed registered IV of 2008 following all the necessary norms the fundamental principles of Trust and their aims and objectives of Trust made earlier as on 09/01/2008 Deed IV of 2008.

AND WHEREAS THIS DEED IS SUPPLEMENTAL to THE DEED OF TRUST registered in the office of the Addl, District Sub- Registrar, Bankura on 08th January, 2008, being Deed No- IV-00004 of 2008.

WHEREAS THE NAME OF THE TRUST is BISHESHWAR PRASAD MEMORIAL EDUCATIONAL AND CHARITABLE TRUST in short BPMECT for all kinds of Educational purposes.

NOW THIS DEED OF TRUST WITNESSETH AND DECLARE AS FOLLOWS:-

1. NAME OF TRUST :The Name of the Trust shall be "BISHESHWAR PRASAD MEMORIAL EDUCATIONAL AND CHARITABLE TRUST in short BPMECT.

2. REGISTERED OFFICE :-The Registered Office of the Trust shall be at St. Xavier's High School, Damodarpur Bankura. W.B, Pin - 722146 and it can be changed at such other place as the Board of trustees may decide from time to time. The trustees may change the name of Trust if they mutually so decided in the future.

3. ORGANIZATION :- St. Xavier's High School Bankura, and St. Xavier's High School, Sonamukhi Bankura is run and Managed by the above mentioned Trust.

4. **AREA OF OPERATION** :-The Trust shall be operated at State level as well as National level, whole India and may be reduced as the trustees may decide.

5. **ADMINISTRATIVE OFFICE** :Branches or project office. Trust may have administrative office or branches or project offices in such place or places as decided by the Secretary/ President of trust or Board of trustees time to time within the Operational area of the Trust under the overall guidance and control of the registered office.



6. **FUND OF THE TRUST** :The assets together with all further donations, contribution, grant and loan in any shape or form will be made to said trust from time to time, and rents, profits and income thereof and the stocks, funds and properties representing the same shall be held by the Trustees upon Trust for the object and purposes and subject to powers and provisions hereinafter set out.

At the time of formation of Trust on year 2008 the settler set apart Rs. 11,000/- but now the Settlor is not setting apart any moveable or immovable property by virtue of this amended Deed of Trust.

7. **OBJECTS OF THE TRUST**

Trust will extend its services without discriminating the caste, creed, race and religion but special emphasis will be Poor, educationally backward in particular and weak sections in general. The objects of trust are to:

- 
- (i) To open, fund, establish, promote, set-up, run, maintain, assist, finance support and/ or aid in setting up and to maintain or run Schools, Colleges, University Social service centres, Industrial Training centre.
 - (ii) To establish, Training Centre, and allied education institutions.
 - (iii) To establish, Cultural, and Social Institutions,
 - (iv) To Spread for promotion of education and learning in all branches more specifically in Science and Technology.
 - (v) To train teachers and workers in ideals and practice of the true spirit of the education and learning.

- (vi) To establish research and training centres for the furtherance of education/learning in its various fields and branches.
- (vii) To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- (viii) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- (ix) To function as a Non-communal Trust and as a secular organisation.
- (x) To establish centres for employment generation.
- (xi) To acquire and maintain the movables and immovable properties for achieving and said objects.
- (xii) To advance any other objects of general public utility.
- (xiii) To confer title on eminent personality in the field of science, education, literature, etc.,
- (xiv) To maintain, develop, improve and extend facilities available in the various institutions under the Trust and to introduce additional facilities as may be required for the purpose of education, training, research.
- (xv) To establish, maintain, improve and extend hostel and transport facilities for the benefit of the students of the institutions.
- (xvi) To grant, pay or give scholarships, stipend, prizes, rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in Prosecuting in their studies in Schools, Colleges, educational institutions, technical institutions, art schools or other training, research or educational works;
- (xvii). To undertake, organize and facilities conferences seminars and training programmes, lectures and workshops in all the educational fields;
- (xviii) To create environmental awareness among the students and public, making efforts to protect environment and nature and similar other activities;
- (xix) To establish another Trust for achieving the object and any identical objects out of the fund of this Trust.
- (xx) To construct buildings and other necessary facilities for organization and to acquire land for such buildings in the name of the Trust.
- (xxi) To get the Educational Institutions registered with the registering authorities throughout the Indian Territory in compliance with Law and Rules of the Govt and Semi Govt., Educational and Medical Authorities.
- (xxii) To appoint Teachers, Professors, Technicians, Doctors and all other required personnels for the running of all types of Educational Institutions.
- (xxiii) To cause the sanctions of various funds from various Financial Aid Authorities of the Govt and Non Govt Authorities.
- (xxiv) To obtain money and moneys worth from the donor or individuals and to collect all donations from the citizens of India as well as the non citizens or various Commercial Authorities of India or abroad.

(xxv) To obtain/ affiliation of the courses and degrees of the said Educational Institutions from Recognized Authorities or Foreign Universities, Boards or Association or in any names they are known.

(xxvi) To provide and bring into the society implementations of financial help and financial development of the citizens at large.

(xxvii) To promote services to the society to increase the social status of the citizen at large.

(xxviii) To naturalize the environment throughout the Indian Territory and to do all acts for such a process and to form Institution etc. for such purposes.

(xxix) To purchase all kinds of assets whether moveable, immovable required functioning the Trust for the welfare of students and providing them all kinds of facilities including Transport, Hostel.

The Trust will not perform any illegal or immoral activities.

AND

Generally to do all acts and things as may appear to the Trustees in their directions conclusion to any other purposes as may be found proper by the Trustees.

Thereby to say that the Trustees will be at liberty to all acts as owner and possessor of the Trust Estate for the protection, preservation, investigation, verification transmission, conveyance or each and every proprietary acts and to do all ministerial jobs and acts whatsoever may be necessary in all time to come.

8. NUMBER OF TRUSTEES:-

That the members of the Trust Body will not be less than (two) and maximum no limit and the existing will be entitled to admit or delete any new Trustee members subject to unanimous decisions. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

That any member of the Trust Body except the President and Secretary may be removed by impeachment by the rest of the members of the Trustee by majority decisions.

That the members of the Trustees while meeting and taking decisions and to bring any act jointly will be as "TRUSTEE BOARD"

All meetings of the Trustee Board will be presided over by the President and in her absence by the Vice-President.

9. BOARD OF THE TRUSTEES:-

The Management and control of the Trust and Trust properties shall vest with the Board of The Trustees. The Trust Board may appoint, select new trustees and expand the office of the trusteeship in the Board of Trustees.

That the Trustee Board will constitute as follows as members with description stated hereunder.

10. TERMS OF OFFICE OF THE TRUSTEES:-

The Secretary/ Chief Managing Trustee, unless he voluntarily resigns or otherwise decides, shall continue to be Secretary and Trustee during the term of their natural lives. The President/ Chairman, unless he voluntarily resigns or otherwise decides, shall continue to be President Chairman during the term of his natural life. The other trustees, shall hold their office of trusteeship till they voluntarily resign, or otherwise desires, or becomes disqualified and ineligible under these presents, or being terminated/ expelled by the Board of Trustees.

The Trustees Board may appoint the new Trustees and may also terminate/ expel any Trustee by the Board of Trustees.

These Trustees shall hold office for such duration as may be specified by the board of trustees.

11. DISQUALIFICATION / TERMINATION OF TRUSTEE :-

TERMINATION OF OFFICE OF THE TRUSTEES:

(a) Trustee shall cease to hold office:

- if he dies,
- if he resigns,

- iii) of an unsound mind, or
- iv) a minor,
- v) possessed bad reputation in the best knowledge of the Secreatry/ President of the Trustee Board.
- iii) if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv) if he is found to have acted against the interest of the Trust.
- v) if it is unanimously decided by the Trustees specified in Trust Deed that his continuation in the Office is against the interest of the Trust.
- vi) Upon expiry of the period up to which the Board of trustees have nominated the trustee.

That in case of death of any member of the Trustees, the Trustee Board will adopt and admit a member by unanimous decisions and in no other way. However if the Board fails to take a unanimous decision, the President will have the right of adoption of the member without assigning any reason whatsoever.

The vacancy of any Trustee Members will be filled in by nomination of either the President or the Secretary subject to approval by the existing members, unanimously during vacancy in the said way, the President or Secretary will have the power to take decision in case of tie of the meeting to have the power to take decision in case of tie of the meeting of the Board of Trustee however no posts of any member will remain vacant for more than 3 months.

In case of death retirement and or permanent vacancy of the post of the Secretary and President, any one among his sons (preferably the elder) and in case of non availability of sons, then the daughter preferably the elder daughter of the Secretary and President as the case may be to continue as Secretary and Chief Managing Trustee of the Trust respective in the place of the Trustee so dying, retiring and do all such acts rights and obligations conferred upon the trustee in these present.

Provided that in case of non- availability of any one among the sons and daughters of the President and Secretary the Trust Board shall select, elect, nominate, appoint the Secretary or Chief Managing Trustee by the Majority of votes among the post of Secretary or President as the case may be.

Provided that in case of a minor son or daughter of the President and or Secretary the another guardian to the minor shall represent his post of Secretary and or President respectively till minor attains age of majority.

In case of death, retirement or permanent vacancy of the post of the other executive trustees other than Secretary and President, the Trust shall select, elect,

nominate, appoint any suitable, eligible and fit person after satisfaction from general public in the place of the trustees dying, retiring and do such acts rights and obligations conferred upon the trustee in these precepts.

That notwithstanding anything stated herein before or hereinafter President, and Secretary shall in case of any emergency be authorized to take any decision for emergency affairs and all fulfilling emergency needs. The said decision will however be placed and approved before the Trustee Board in its next meeting.

12. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in the Trust Deed and they shall hold office for such duration as may be specified by the Board of Trustees. Vacancies in the Board may be filled by the remaining Trustees at the meeting called for the purpose. Casual Vacancies in the Board may be filled in the manner aforesaid for the unexpired part of the term of the Trustee causing the Vacancy. A retiring Trustee shall be eligible for re-election on the recommendation of Chairman. Vacancies in the Board shall not invalidate the any of the Proceedings of the Board.

13. MEETING OF THE TRUST BOARD :-

That the Trustee Board shall meet at least 2 (Two) times a year at a gap of six months in ordinary course or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

In any occasion emergency Trustee Board may be called by the President or the Secretary at any time subject to three days' notice to each member indicating the business to be transacted or discussed.

14. QUORUM:

The Quorum for the Meeting of the Board of Trustees shall be 2 (TWO) numbers quorum is required for a meeting adjourning for want of Quorum.

A minute book shall be kept by the Managing Trustee. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

The PRESIDENT/ SECRETARY shall call for a meeting of the trust Board once in three months by giving 7 days notice. The quorum on which meeting shall be TWO including the PRESIDENT /SECRETARY.

Decision at the meeting of the Board shall be taken by the Majority of the Trustees present by unanimous decision or voting. In the case of equality of votes, the Chairman of the Board shall have a second casting vote.

15. NOTICE.

7 days Notice shall ordinarily be given in writing for a meeting of Board of Trustees.

16. VOTING.

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

17. POWER AND FUNCTIONS OF THE TRUST BOARD :-

That the Trustee shall have the following powers:-

(a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

(b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

(i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.

(ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.

(iii) To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.

(iv) (a) To raise loans, to receive monies, securities or other movable property on behalf of the Trust.

(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.

(v) To award scholarship and make donations calculated to promote the objects of the Trust.

(vi) (a) To enter into contracts, or engagements on behalf of the Trust.

(b) To consider such proposals submitted by Sub-committee appointed by this trust and allocate such funds if necessary as deemed necessary for the implementation of the programs.

(vii) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

(viii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.

(ix) To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.

(x) To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.

(xi) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.

(xii) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.

(xiii) To frame Bye-Laws and such other regulations as are required for achieving its objectives.

(xiv) To pay all expenses relating to the affairs, administration and management of the Trust.

(xv) To conduct correspondence on behalf of the Trust.

(xvi) To get the accounts audited at the end of the year.

(xvii) To demand , realize and receive all interest, dividends, rent and investment from persons, firms or companies and public debt officers liable to pay the same.

(xviii) To deposit the income of the Trust fund with the Bankers of the Trust appointed by the Trustees who may be bank or any Firm, Company or Individual on such terms as the Trustees may decide and also can take loan from Bank/ Financial Institutions.

(xix) To compromise, compound, abandon, submit to arbitration or otherwise settle any debt, account, claim or dispute or suit relating to the affair of the Trust, its funds, properties or the investment for the time being.

(xx) To nominate, constitute and appoint attorney or agent and delegate to such attorney or agent all or any of the powers vested in them under their presents.

(xxi) To accept donations, contributions, either in cash or in kind for the object and purposes of Trust from any persons if the Trustees so approve and on such terms and subject to such conditions as may be agreed to.

(xxii) The Board of Trustees will have the power to amend, incorporate any additional provisions in future with the consent of majority in a meeting of the Board of Trustees.

(xxiii) To frame, and with a notice of one month vary, amend or alter, scheme, Rules, Regulations and bye-laws for the management and administration of the Trust, its properties and the institutions run by the Trust.

(xxiv) To transfer the trust property or any portion thereof by way of sale, lease, license, mortgage, trust will and etc. in favour any other trust, society, local body, charitable, agency organization. Etc. having the same aims and objectives and believing the same ideals, mentioned in this present in order to implement any objects of this presents.

(xxv) To take all other steps necessary to carry out the objects and purposes of the Trust or the affairs thereof or otherwise to give effect to the object and purposes of the Trust.

(xxvi) The Trustee shall have the power to initiate, prosecute and defend any proceedings before all law courts, form and authorities.

(xxvii) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely

- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
- (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
- (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.

After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

18. BOOK ACCOUNT:

- (i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of BISHESWAR PRASAD MEMORIAL EDUCATIONAL AND CHARITABLE TRUST such accounts shall be jointly operated by the President and Secretary.
- (ii) The trust may open Bank Account/s in the name of institution/organisation founded by the Trust. Such Bank Accounts shall be operated by such persons as authorised by the board of trustees from time to time.

19. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any

trustee in connection with the work carried out by him/her for the purpose of the Trust.

20. FINANCIAL YEAR :-

(i) The accounts of the Trust shall be closed on the 31st March every year and the statement of Income and Expenditure for the financial year and assets and liabilities shall be drawn at the date which shall present a true picture of the affairs of the Trust.

(ii) The Trust may receive contributions and donations in Cash, Cheques or any kind and also immovable properties, valid receipt shall be issued for all the donations received. The Trust funds shall be involved for the betterment of the Trust in any manner as the founder trustee/ Secretary deems fit including the securities as recognized by the Income Tax Act in the force from time to time for the use of the Trust.

21. FINANCIAL POWERS AND FUNCTIONS:-

1. To borrow if needed against the secured of the assets of the trust by way of bank overdraft, loan or otherwise as may be necessary for the benefit of the trust for any financial agency and for more effectively carrying out the objects of the trust. And to borrow, if needed by executing bonds of otherwise from the trustees of these presents as may be necessary for the benefit of the trust and for effectively performing the objects of the trust.
2. To spend any portion of the corpus of the income of trust fund for purchasing any and or constructing any building or buildings for any in the name of trust for the purpose of carrying out, promoting and or executing any or all of the objects of the trust.
3. To accept, receive and or cause to receive any donation or contribution grants in cash or in kind or in any form whatsoever from any person, firm, govt, company, corporation, society or the Trustees for the furtherance of the objects of the trust upon such terms and conditions as the board of trustees may in his absolute discretion think fit and which are not inconsistent with the objects of the trust. The Board of trustees may also take over the management of any other charitable or public institutions on such terms as he thinks fit and may manage administer supervise such institutes.

22. MEETING OF THE TRUST:-

The Board of Trustees should meet at least once in every calendar quarter and may meet more often when required.

(a) The meeting of Board of Trustees shall be convened by the Managing Trustee and he shall preside over the meetings. In his absence, the Managing Trustee may authorize the Vice President to be the Chairman of such meetings. In the event the Managing Trustee or Vice President are not able to attend the meeting already convened, any of the Trustees present in the meeting may elect one amongst themselves to be the Chairman of the meeting.

(b) One half of the Board of Trustees or a minimum of two trustees, whichever is higher, shall constitute the Quorum for the Board of Trustee meetings.

(c) All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the Chairman presiding over the meeting shall have a casting vote.

(d) Any resolution in writing signed by all the Trustees by circulation shall have equal force as though it has been passed at a meeting of the Board of Trustees.

(e) The meeting of the Board shall be conveyed after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.

(f) The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled to vote in the meetings of the Board.

23. QUORUM:-

Three Trustees at a meeting shall form a quorum for any meeting of the Trust Board, Notice of the meeting of the Trustees and all communications may be sent to the trustees at their present residential address. The President and Secretary, are members of the quorum.

24. BANK ACCOUNT :

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other money from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a bank account with any scheduled bank for the purpose of the Trust. The bank accounts shall be operated by the Managing Trustee along with any one of the remaining Trustees. One or more Bank Accounts may be opened in any Bank and/or Banks in the name of the Trust. The Secretary and President of the Trust will deal/look after and operate total financial matters of the Trust and both of them will be the signing authority and take final decision o the Trust without any interruption by other trustees for smooth functioning of the Trust

25. ACCOUNTS AND AUDIT :

The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Board of Trustees. The Trustee

shall maintain proper books of account of all the assets, liabilities and income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March. The accounts of the Trust shall be annually audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

26. IRREVOCABLE:

This Trust is declared irrevocable.

27. RESIDUARY POWER :-

Any matter not provided for in these prevent shall be dealt with by the absolute discretion of the trustees.

28. AMENDMENTS:

While this Trust shall be irrevocable, the Board of Trustees may amend any of the clauses except those relating to objects of the Trust. The PRESIDENT and SECRETARY may do so, at a duly convened meeting of the Board with at least two weeks' notice, and by a resolution passed by atleast three-fourth majority of the Board of Trustees present and voting. The amendments to the Trust deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation. If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the Commissioner of Income Tax and these shall be read together with the main Trust deed.

The Board of trustees may make any amendments, add to the rules, he may consider necessary for the better management of or administration of the Trust and Trust properties and Trust objectives. Addition/ Alteration or any changes will be passed in the Trust Board meeting and a resolution shall be passed by the Board of Trustees.

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and 80G of the Income Tax Act, 1961 as amended from time to time.

29. SECRECY :-

The Trustees shall maintain the confidentiality of the trust. Trust properties and its affairs.

30. SEAL :-

There shall be a common seal of the Trust, which shall be affixed at the direction of the Trustees the composition of the said seal may be altered from time to time upon the discretion of the Trustees.

31. INDEMNITY TO THE TRUSTEES :- The Trustees shall not be answerable or accountable to acts, receipts, neglects and defaults done in any matters or by any other person with whose or into whose hands the money or securities may be deposited or come in accordance with these presents nor for the determinations or damage or loss of any funds, deposits or securities nor for any defects or insufficiency of funds or for any other losses unless the same shall happen by his negligence.

32. POWER TO REIMBURSE :- The Trustees of these presents are entitled to be reimbursed themselves and also pay and discharge of the trust fund all expenses incurred by them or in or about the execution of the trust or any of their duties under these presents including travelling expenses and etc. The Trustees may act as Directors administrative officer, or in any responsible posts or any educational institutions, organizations established, managed and administered under the present by the Trust as an employee and in such case, the trustee so presented and working shall be entitled to any salary honorarium allowances as admissible to such or duty or assignment as per the decision of the Trust Board.

33. NATURE OF THE TRUST :-

The trust shall function as non-profitable, secular, non proprietary and non-political trust. It is further declared that all the incomes, earnings, moveable's or immovable properties of the trust shall utilized and applied for promotion, development and implementation of its aims and objects as set under these presents. No trustees of the Trust shall have any personal claim on any movable or immovable properties of the trust or make any profits. Whatsoever by virtue of trust the educational institutions of the Trust shall work in conformity with the State Government does if any governing the field.

34. COOPERATION AND LIBATION AND AFFILIATION :-

The Trust can become an affiliated member of any national or international organization, institutions having similar aims and objectives. The Trustees may established and develop mutual areas of cooperation with different organizations and international, national, regional, local voluntary and official agencies and

also specialized institutions, groups and individuals and such other associations, federations in furtherance of the aims and objectives of Trust. The Trust under these preserves right to grant accord, give affiliation recognition, permission, approval of any organizations instructions and international, national and official agencies and also specializes notifications, groups and individuals and such other associations, societies, federations and individuals and such other associations, societies, federations in furtherance of the aims and objectives of the Trust.

35. UTILIZATION OF TRUST FUNDS:-

All activities financed from the trust shall be utilized in accordance with the ideals and objectives as stated herein and no discrimination shall be permitted therein on grounds of religion, caste, cred of sex provided that any donation, grants, assistance, etc earmarked and accepted for any specific purpose falling within the objects mentioned in these presents shall be used for such specific purpose.


36. EXCHANGE OF IDEAS NAD EXPERIENCES:-

The Trust and trustees may act as a channel for inter change of ideas and experiences created through innovations by training workshops, seminars, conferences, meetings, symposium, discussion, demonstrations, exhibitions and publications and etc.

37. ACQUISITION OF TRUST PROPERTY BY GOVERNMENT

39. AMALGAMATION ,

The trustees may amalgamate the Trust with another Charitable Trust or Institution having similar objects with prior permission of the Charity Commissioner/Court/any other law as may be applicable for the time being.

40. APPLICABILITY OF TRUST ACT :

The provisions of the Indian Trust Act, 1882 (or any other applicable state specific trust Act) shall apply to all matters not specifically mentioned in these presents.

41. DISSOLUTION:

In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/Organisation whose objects are similar to those of this Trust with the permission of the Charity Commissioner / Court / any other law as may be applicable for the time being. The Trustees shall be indemnified against all losses and liabilities incurred by them in the execution of the Trust and shall have a lien over the funds and properties of the Trust for such indemnity.

42. ALTERATION OF THE BENEFITS CONFERRED BY THE TRUST:-

In the event of a change of circumstances making it impossible to continue any of the objects of the Trust, the Secretary shall apply the Trust Funds and the property to any other subject of like nature or to any other institution or Trust having similar objects.


43. ALTERATION OF CLAUSES OF THE TRUST :-
